





Grant Writing for Success

Hallmarks of an Outstanding Grant Application

- Strong significance for an important problem in public health: IMPACT is high
- High degree of novelty and innovation
- Strong track record of a well qualified applicant with compelling publications
- Clear rationale
- Relevant and supportive preliminary data
- Clear and focused approach that provides unambiguous results
- Careful attention to details: spelling, punctuation, grammar, fonts, clarity of data, error bars, spelling, etc.

Common Reasons Cited for a Weak Application

- Lack of or weak impact
- Significance not obvious or weak
- Too ambitious, lacking focus, too many unrelated aims
- Unclear or flawed hypothesis or rationale
- Applicant track record weak or lacking appropriate expertise
- Feasibility unsupported
- Approach flawed
- Poor writing and lots of errors


What Reviewers Look for in Grant Applications

- Significance and impact
- Exciting ideas
- Clarity
- Ideas they can understand don't assume too much
- Realistic aims and timelines don't be overly ambitious
- Brevity with things that everybody knows
- Noted limitations of the study
- A clean, well-written application

Common Problems in Applications

- Lack of new or original ideas
- Absence of an acceptable scientific rationale
- Lack of experience in the essential methodology
- Questionable reasoning in experimental approach
- Uncritical approach
- Diffuse, superficial, or unfocused research plan
- Lack of sufficient experimental detail
- Lack of knowledge of published relevant work
- Unrealistically large or overly ambitious amount of work
- Uncertainty concerning future directions
